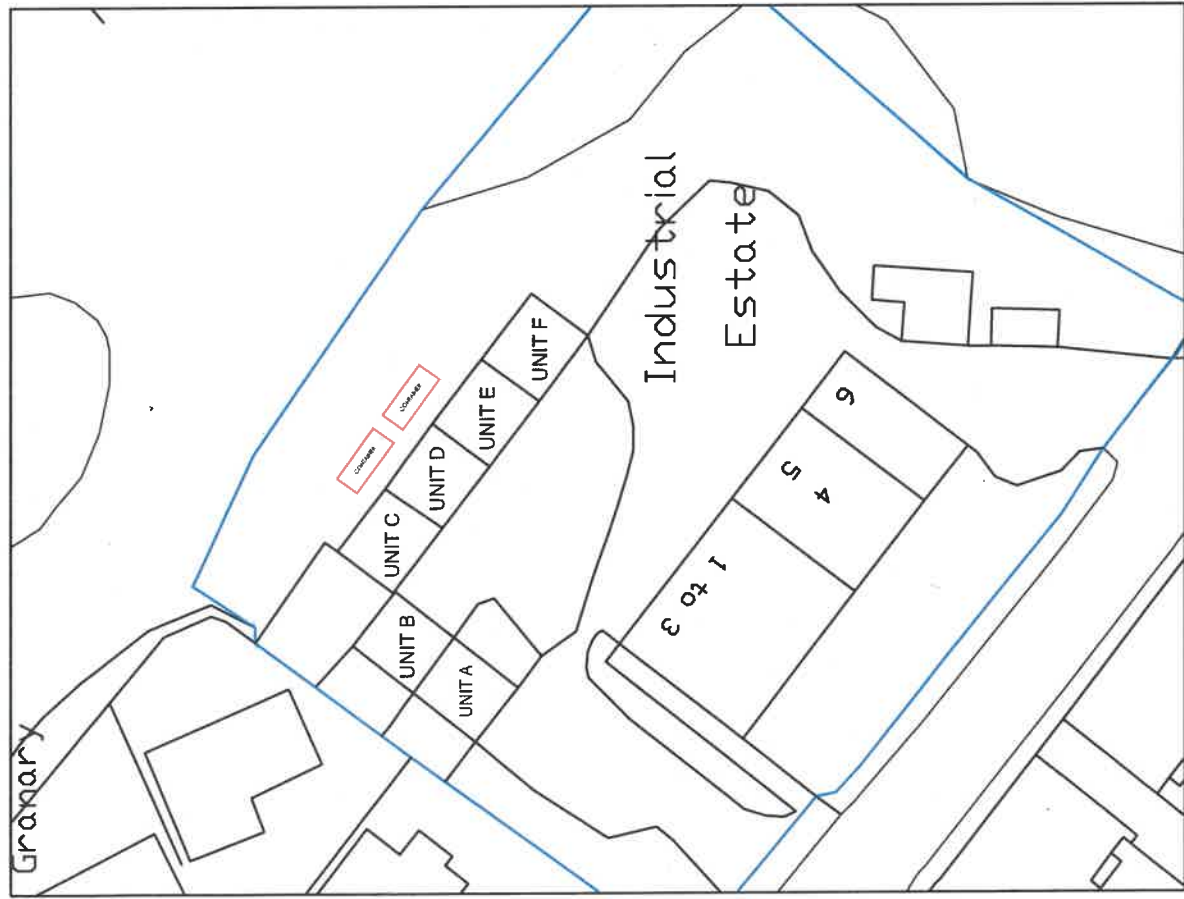

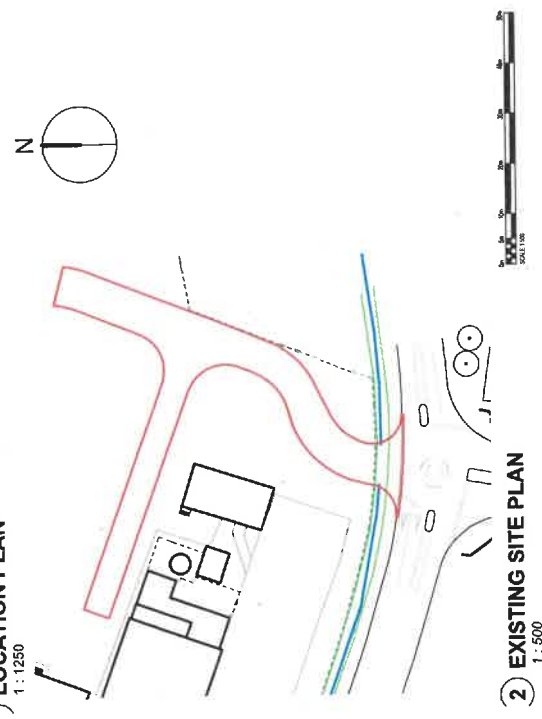
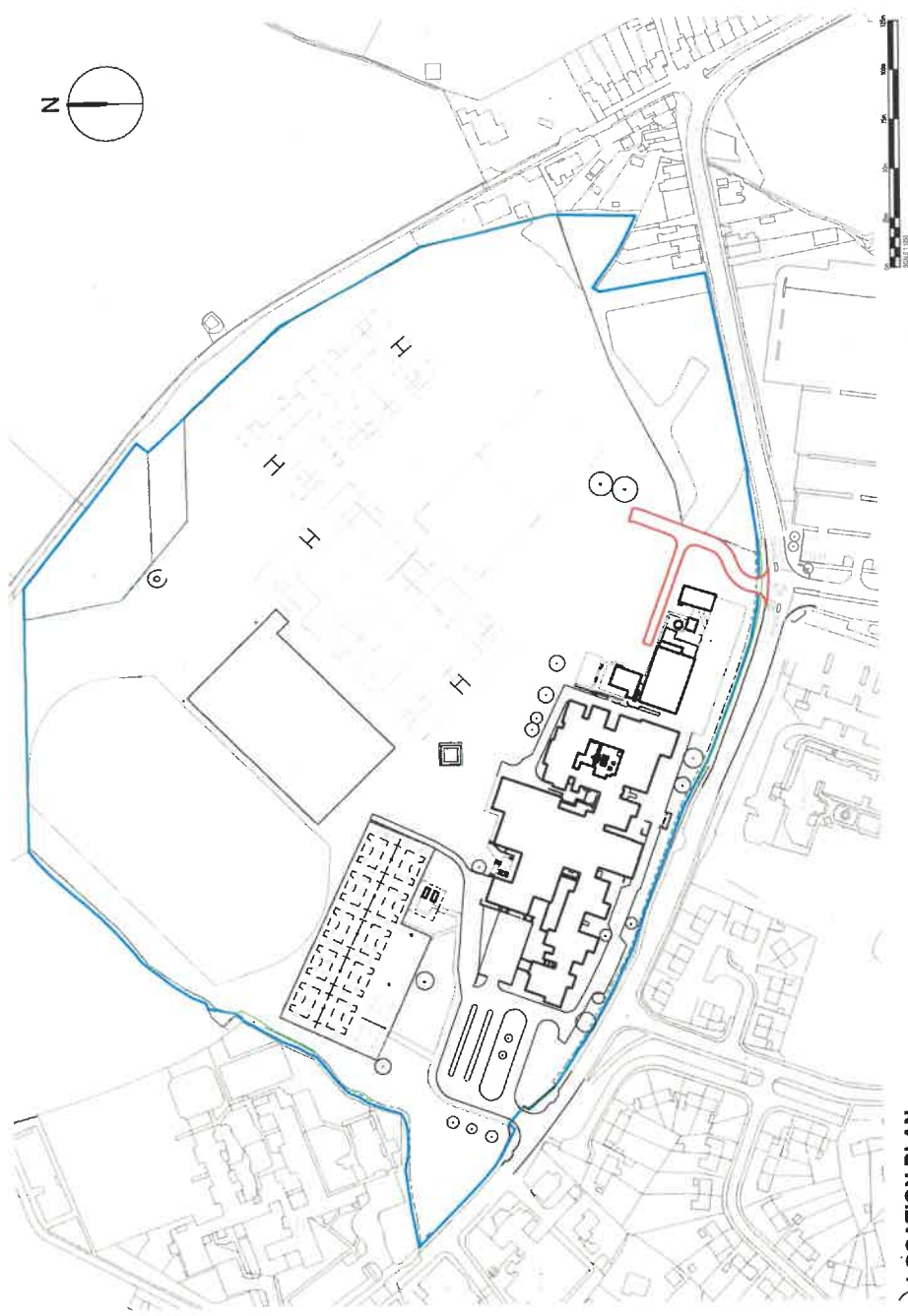


**Site Block Plan 1:500**

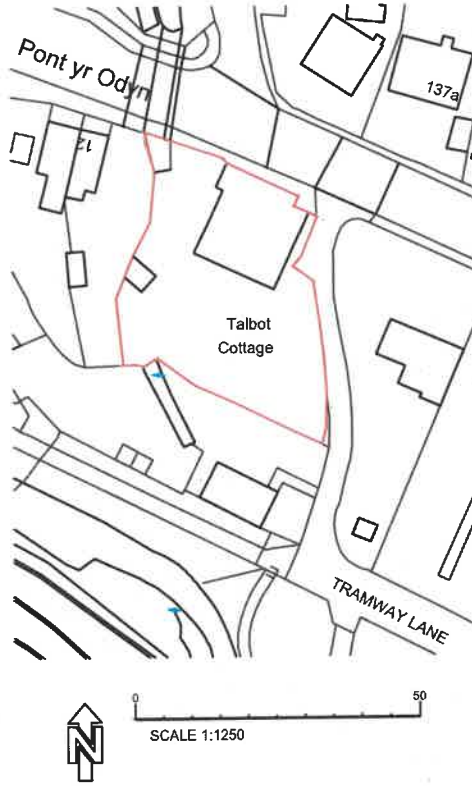


**Site Location Plan 1:2500**

<b>The following application has been determined under the Clerk's delegated powers:</b>		
<b>PL/06963</b>	Mr D Bowler Land at Stradey Hill Pwll Llanelli (Hengoed Ward)	Proposed detached dwelling and ancillary garage.

Recommendation – objection on the following grounds:

1. Stradey Hill and the immediate surrounding area had been over developed and the proposal was considered to be detrimental to the public sewer system with it also having a negative impact on the general amenity of the area. It also would have a detrimental impact on the existing over developed built environment and would have an overbearing effect on the immediate street scene and surrounding properties. Overall this development was likely to have a negative impact on local biodiversity generally.
2. There were highway safety concerns over the access and egress arrangements leading on to the site from Stradey Hill, which effectively was a single carriageway for most of its length and which already experienced a high volume of traffic movements combined with indiscriminate car parking which obstructed pedestrian access with cars parking on the pavement and over hanging on to the highway. Further development would be detrimental to highway safety standards with it having a negative impact on current traffic flow and general congestion for existing road users and pedestrians living in the immediate area. Local access arrangements would be further undermined.

The consequence of the amendment is:

and will replace the existing prohibitions and restrictions (if any) that affect the parts of road shown on the plans bearing the unique reference numbers specified in column 3 of each of the Schedules referred to above.

2. To revoke:

- (a) The County of Carmarthenshire (County of Carmarthenshire with the exception of Carmarthen, Llanelli and Ammanford) (Waiting Restrictions and Street Parking Places) Consolidation Order 2004;
- (b) The County of Carmarthenshire (with the exception of Carmarthen, Llanelli and Ammanford) (Waiting Restriction and Street Parking Places) Consolidation (Variation No. 9) Order 2011;
- (c) The County of Carmarthenshire (County of Carmarthenshire with the exception of Carmarthen, Llanelli and Ammanford) (Waiting Restriction and Street Parking Places) Consolidation (Variation No. 22) Order 2015;
- (d) The County of Carmarthenshire (County of Carmarthenshire with the exception of Carmarthen, Llanelli and Ammanford) (Waiting Restriction and Street Parking Places) Consolidation (Variation Number 37) Order 2021; and
- (e) The County of Carmarthenshire (Llanelli) (Waiting Restriction and Street Parking Places) Consolidation (Variation No. 27) Order 2013;

insofar as the same relates to the restrictions briefly described in Schedules 9, 10, 11 and 12 to this Notice and more particularly shown on the plans bearing the unique reference numbers specified in column 3 of the said Schedules.

The provisions for the usual exemptions contained in the Consolidation Order will apply in relation to the roads referred to in paragraphs 1(a)-1(h) above. These include the right for passengers to board or alight from a vehicle, for the loading and unloading of goods, for the carrying out of building operations and other works, for the performance of statutory powers or duties and to enable a vehicle to take in petrol, oil, water or air from any garage situated adjacent to such parts of road affected by the proposed restriction.

In addition, the Consolidation Order contains the usual parking concessions for disabled persons in accordance with the Blue Badge Scheme.

## **STATEMENT OF REASONS**

**The County of Carmarthenshire  
(with the exception of Carmarthen, Llanelli and Ammanford)  
(Waiting Restrictions and Street Parking Places)  
Consolidation (Variation No.41) Order 2024**

1. Prohibition of Waiting is being provided to prevent parking in the vicinity of a junction to facilitate better visibility and the free flow of traffic at the following locations:
  - Isgraig, Burry Port.
  - Cwm Ivor Road, Burry Port.
  - Victoria Street and Market Street, Laugharne.
  - Heol Gwermont, Llansaint.
  - Elkington Road, Burry Port.
  - Grove Hill Park, Gorslas.
  - Derwydd, Ammanford.
  - Caemawr and Betws Road, Ammanford.
  - Ebenezer Road, Newcastle Emlyn.
  - The Avenue, Llwynhendy.
  - Station Road, Llandeilo.
  - Hen Heol y Banc and Heol y Felin, Bancffosfelen.
  - Heol y Bwlch and Clos y Gerddi, Bynea.
  - Lewis Street, Bridge Street and Pencader Road, Pont-Tyweli, Llandysul.
  
2. Prohibition of Waiting is being provided to provide the free flow of traffic, maintain safe access for off-street parking and prevent double-parking at the following locations:
  - Llanboidy.
  - Llethri Road, Llanelli.
  - Darren Las and Lletty Road, Tumble.
  - Parc y Minos, Burry Port.
  - Hendre Road, Llangennech.
  - Lon yr Ysgol, Dafen.

- Access Road leading to Mynydd Mawr Woodland Car Park Area, Tumble.
3. At **Queen Street in Llandovery**, revocation of prohibition of waiting between Monday to Saturday between the hours of 9.00 a.m. and 6.00 p.m. and the implementation of a prohibition of waiting at any time is to prevent double-parking on a narrow section of highway and to ensure the continuous free and unobstructed flow of traffic.
  4. At **Newbridge Road in Laugharne**, the prohibition of waiting is being provided to prevent parking on a very narrow stretch of highway, allowing better egress for visitors to a local hospitality business.
  5. At **Burrows Terrace in Burry Port**, the prohibition of waiting at any time is being provided to improve forward visibility to the children's play area.
  6. On the road leading to **Ysgol Griffith Jones and Clos Griffith Jones in St. Clears**, the prohibition of waiting at any time is being provided to prevent vehicles causing an obstruction to the thoroughfare and junction.
  7. At **Pentwyn Road in Betws**, the prohibition of waiting at any time is being provided to restrict parking where there is regular pedestrian activity and improve safety for pedestrians along Pentwyn Road.
  8. At **Heol Llannon in Pontyberem**, the prohibition of waiting at any time is being provided to improve access, visibility and improve access to a bus stop area.
  9. At **Ferry Road in Kidwelly**, the prohibition of waiting at any time is being revoked to allow the provision of a Disabled Parking Bay.
  10. At **Bryndauddwr and Maes yr Ysgol in Peniel and the road passing Bro Myrddin School, Carmarthen (C2073)**, the prohibition of waiting at any time and prohibition of Loading or Unloading is being provided to prevent parking around the schools, improving road safety for pedestrians.
  11. It is proposed to provide No Loading or Unloading in the vicinity of **Tycroes and Furnace Schools** to prohibit stopping by vehicles at the start and finish times of each school. Parked and stopping vehicles have been identified as a hazard to children walking and cycling to school.



12. At **Heol y Garreg Las in Llandeilo**, the prohibition of Loading, Unloading or Waiting is being provided to prevent stopping or parking on verges and along a narrow section of road.
13. At **Bassett Terrace in Pwll**, the time-limited parking is being provided to provide additional short-term parking to support nearby businesses.
14. At **Waterloo Road in Penygroes** and **Bryngwili Road in Cross Hands**, the limited waiting is being provided for additional short-term parking to support nearby businesses.
