447. COMMUNITY FACILITIES – MAINTENANCE WORKS

RESOLVED that the Facilities Manager's report on work undertaken be noted.

448. FURNACE COMMUNITY HALL STORAGE AREA

Members considered correspondence from the committee members, Llanelli Woodturning Club seeking permission to increase the floor space needed to support club activities by further extending into the adjacent basement storage area at Furnace Community Hall. Members were informed the storage area was being used by the council on an ongoing basis and officers cited various examples of how the council utilised the space, and following discussion it was

RESOLVED that permission be refused on the basis the council needed the storage area for its own purposes.

449. TRALLWM COMMUNITY HALL CAR PARK

Cllr. T. M. Donoghue declared a personal and prejudicial interest in the following item as she was a committee members of Trallwm Hall Management Committee and left the meeting before discussion commenced.

Correspondence was received from Tiny Tots Town requesting permission from the council to have daily access to the council's car park which was situated to the rear of Trallwm Community Hall.

Tiny Tots Town was based in the building next door to Trallwm Community Hall and had a parking facility for eight vehicles. Due to the success of the business, the proprietors enquired if they could have shared access to the council's car park facility to the rear of Trallwm Community hall. If an agreement was made, this would free up vehicles parking on the highway.

Following discussion it was

RESOLVED that:

1. The request be held in abeyance for the time being.

2. Officers continue to have discussions with Trallwm Hall Management Committee over the extent of the use of the hall car park by hall patrons.

3. If ultimately, there was general consensus and agreement between the parties over sharing the hall car park with the patrons of Tiny Tots Town, the matter shall be reconsidered by the council with a view of formulating a business plan to regularise the agreement, premised upon parking arrangements at the council's other community facilities, and that such an arrangement shall be enacted directly with the council.

450. DAFEN PARK – BOWLS PAVILION

Cllrs. N. Evans and R. E. Evans declared a personal interest in the following item as they were members of Dafen Welfare Hall Management Committee. Cllr. S. N. Lewis declared a personal interest in the following item as she was the Treasurer, Dafen Welfare Hall Management Committee. Cllr. A. J. Rogers declared a personal interest in the following item as he was the Secretary, Dafen Welfare Hall Management Committee.

Members received correspondence from the Secretary, Dafen Welfare Bowls Club requesting permission to erect a ramp to facilitate disabled access to the bowls pavilion.

The current access to the pavilion was via high steps and a grab rail which did not comply with the Disability Discrimination Act 1995 (DDA). The new facility would comply with the DDA 1995 and the cost would be funded by the club.

RESOLVED that permission be granted to Dafen Welfare Bowls Club to provide a disabled access ramp at the pavilion at its expense and that the club be advised to check with Carmarthenshire County Council, whether planning permission was required before proceeding with the proposal.
