In the summer period the majority of the time focusses on ground maintenance activities, whereas in the winter period the focus switches more to buildings' maintenance activities. Cemetery and Porterage activities are performed throughout the year.

The Council has put in place a preventative maintenance budget based on an annual list of priorities and to cater for day to day contingencies. By adopting a preventative approach this supports sustainable development principles. The cyclical annual maintenance programme ensures community assets are kept in good order, extending the life cycle of the assets over many years.



I am writing on behalf of the sporting organisations of Felinfoel RFC, Felinfoel AFC and Felinfoel Cricket Club that regularly use the changing rooms and showers at the Phil Bennett Resources Centre.

As you are aware, the showers in the changing rooms are once again out of order. At the time of writing, the showers have been non-functional for nearly two weeks, providing only cold water. Unfortunately this is not an isolated incident, such breakdowns are becoming increasingly frequent and are severely impacting the activities of all the sporting groups.

The inability to provide hot showers has led to the cancellation of games, often at short notice, which causes inconvenience to visiting teams and damages the reputation of the clubs and village. This issue is particularly pressing as the facilities are used by players of all ages, from U7's to senior teams and the arrival of the colder wetter months further emphasises the need for reliable hot water.

As you know, resolving these issues is rarely a quick process. The systems complexity, coupled with the increasing difficulty in sourcing replacement parts, results in lengthy delays. The gas engineers have indicated that parts for the existing systems are becoming harder to obtain, raising the concerns that the showers may eventually be permanently out of action. This could lead to significant unplanned costs for the council to replace the system entirely.

Given that the hot water boiler system has been in place since the building opened in 2011, I would strongly request that the council review its efficiency and reliability. Proactively replacing key components of the system would not only resolve the ongoing reliability issues but could result in reduced running costs for the centre as modern boiler systems are significantly more energy efficient.

I kindly ask that this request is referred to the Recreation and Welfare Committee for their consideration. Additionally. I would appreciate it if you could provide me with and update at your earliest convenience so that I can inform the affected sporting groups of any progress.

Thank you for your attention to this matter, and I look forward to your response.

Good Afternoon,

I'm getting in touch as we've been advised by Cllr Martyn Palfreman that the Rural Council would be in support of the installation of a Bus Shelter on the piece of land adjacent to the footway fronting the Community Hall. A possible opportunity has arisen to include the installation of a shelter in proposals to improve the Sandy/Maes-y-Coed junction. These proposals will be subject to a full public engagement exercise and their progression dependent on a successful funding application.

I just wanted to firstly check that this is correct, and secondly confirm that we are on the same page with regards to a few details.

The attached land snapshot shows that the parcel of land adjacent to the footway is contained within the land title of the Community Hall, and as such is within control of Llanelli Rural Council.

It is envisaged that a shelter (design TBC) would be installed on that piece of land owned by Llanelli Rural Council to maintain full footway width fronting the Community Hall. We would be happy to liaise with Llanelli Rural Council to reach a design and specific location which suits all parties.

Given the land is within Llanelli Rural Council ownership the shelter would become a Llanelli Rural Council Asset. Carmarthenshire County Council do not, at this time, hold a maintenance budget for bus shelters and as such full responsibility for the maintenance would sit with Llanelli Rural Council.

Please let me know your thoughts on the above. I'm happy to convene a short meeting to discuss further, if required.
