**145. SAFER ROUTES IN THE COMMUNITIES SCHEME
FIVE ROADS RECREATION GROUND
NEW PATHWAY**

Members received a request from Cllr. A. Evans seeking permission from the council for the creation of a new pathway to be constructed in Five Roads Recreation Ground in support of the successful application to the Safer Routes in the Communities scheme.

Following discussion, it was

RESOLVED that permission be granted in principle for the work to commence at Five Roads Recreation Ground for the creation of the new pathway subject to receiving a plan of the proposed route. Once the work had been completed, the council would take on the

responsibility for the maintenance of the pathway, including meeting the cost of energy charges associated with public lighting, if it was ultimately decided to install footway lighting columns along the route of the pathway, as part of the scheme.
