1. That Llanelli Rural Council call on the Welsh Government and the Welsh Health Secretary, Jeremy Miles, to intervene and stop Llanelli's urgent care provision from being further cut by Hywel Dda. The largest town in West Wales should have an A+E department but now we do not even have a full time Minor Injuries Unit.

Health is a devolved matter and it is only right that Welsh Government and Health Secretary step in and prevent further cuts to services in Llanelli.

2. Llanelli Rural Council reiterates its support for the SOSPPAN Campaign to maintain the MIU at Prince Philip Hospital as a 24/7 doctor led unit.
