# 294. THE FINANCE AND GOVERNANCE TOOLKIT FOR COMMUNITY AND TOWN COUNCILS

Further to Minute No. 280, members received the Finance and Governance Toolkit which had been prepared by the Finance and Governance Working Group.

Community and Town Councils were responsible and accountable for the conduct of public business and for spending public money. By law, councils needed to ensure they safeguarded, properly accounted for, and used public money they had been entrusted with economically, efficiently and effectively.

All councils were expected to have high standards of stewardship, this began with compliance with legal requirements but over and above this it was about achieving the best outcomes for the people and communities the council served.

The toolkit helped the council assess whether the council was meeting certain statutory requirements that external auditors and the public would expect to see. It was about providing assurance that the council was operating effectively.

**RESOLVED** that the completion of the Finance and Governance Toolkit for Community and Town Council be noted and accepted.
